Please read the below eligibility, prize details, terms and conditions, timeline and voting process

Eligibility –

1. All songs submitted must be original works, no covers will be accepted.
2. The contest is open to solo musicians and bands not exceeding 10 musicians.
3. Participants may be involved in up to three various group entries.
4. 75% of your band/group must reside in Gippsland or have grown up in Gippsland, if you have moved out of the region you are welcome to apply, however proof of being from the Gippsland region will be required, e.g. Old identification including school id cards. 25% will be allowed from anywhere in Australia.
5. It is open to all levels both professional and non-professional musicians of any genre of music.
6. Obscene language, themes of violence, racism, sexism, sexual abuse and harassment and any content which is derogatory towards any marginalised group in society will not be accepted and these videos will not be uploaded.
7. Be aware that music of a political nature will be monitored and assessed on a case by case basis for eligibility, this is not an event for political statements.
8. Entrants under 18 years of age will be accepted, only with parental / guardian consent.

Prize Details – 3 Prize Winners – 1 Prize Per winning artist/band

- 1x 20minute set at the Esso Night Under the Stars, presents Gippsland Live in 2021
- Concert performance fee of \$500.00 (flat rate, non-negotiable), dinner, non-alcoholic drinks, and car parking for the concert will be provided.
- All winners will receive free entry to the event plus 4 free tickets each (4 for each band member) for family or friends. No more than 4 tickets will be issued, any extra tickets will need to be paid for by the purchaser.
- Complimentary publicity in the form of social media posts across all the participating venues will be in the forms of more video music content, interviews, photos, bios, etc. will be developed and published in the lead up to the concert. It is requested that winners make themselves available for media promotion in the lead up to the concert.

Terms and Conditions

1. All content received will be protected by council's data privacy and protection policy and only approved artists details will be shared. All contact details will be protected in accordance with the policy.
2. All entrants must adhere to the eligibility guidelines, Gippsland Live organisers reserve the right to return and not upload any content which does not meet the criteria.
3. All entrants must submit a photo of current identification which shows a current Gippsland residential address. Anyone who does not provide this detail will not be eligible for entry to the competition.
4. If prize winners are not available for the live concert, the fourth runner up will then take their place. In the event they are not available, it will go to the 5th runner up. If all runner up to 10th place is unavailable, then the acts able to perform will be granted 30-minute set times.
5. All media and concert marketing will be managed by the venues and not the artists. Any marketing developed by the artists will need to be approved by the event organisers before being published.
6. All concert material will also be subject to rules 5 and 6 in the eligibility guidelines. Event organisers have the right to refuse the winner a place in the concert if they do not adhere to this rule. Separate terms and conditions for participation in Esso Night Under the Stars will be provided in the artist performance agreements.

Two voting streams:

1. Public vote
2. Peer vote (5 voters in total, 1 from each municipality)

Two rounds of voting:

Round 1: open to all entrants, this round will begin accepting content into the Google Drive folder or sending link to YouTube videos.
